Dear Ambassador of EU Member State / Consul General

I am writing to you as I am having problems claiming my rights as an EU citizen, to invite your intervention to guarantee the rule of the law within EU member states, and to avoid further incidents with the Italian Consulate.

To comment on this situation I wrote a book and in Appendix there are several documents concerning this situation I reported immediately to the competent authorities from the start.

As you can see I arrived in England because I had a PhD offer, but I become paperless like an illegal immigrant and the Italian Consulate never provided any assistance despite I solicited several times.

In 2005 the EU-OLAF sent lawsuit to the Court in Milan, but the Prosecutor swept the case under the carpet pretending it has never happened, as did the Prosecutor in Verona where I sent lawsuit shortly after (Denuncia alla Procura della Repubblica presso il Tribunale di Verona).

As you can see, concerning this situation I recently contacted the LOCAL POLICE in Yorkshire (09 October 2020 Ref Num 0962 - meeting on 13 October 2020. In attachment on DVD) with the intention to PRESS CHARGES. I would have liked to address my complaint to a lawyer, but without a passport I don't have the rights to hire a lawyer (Tim Barber, Solicitor explains page 219).

So I report this to your office concerning the Rights EU Citizens are supposed to have but cannot claim, and the assistance I had from the Italian Consulate.

As you can see from the documentation, after EU-OLAF sent lawsuit to Milan, I was advices to press charges against the Italian Foreign Office (Paul Diamond, barrister, 2008, pag 225; MP Bill Rammel, Minister for High Education, Tony Blair Gov., 2008, Pag 207), but shortly after I was arrested in England with false accusations, appropriate intimidations to cover up the situation as I was still paperless and claiming for my Rights.

As you can see from the video, the Police informed that at the moment there are no accusations against me, the false accusations I was targeted were unsubstantiated (intimidations) and I have never been prosecuted, just arrested with false accusations and stocked into a high security cell as a terrorist. All thanks to the assistance of the Consulate in making me paperless like an illegal immigrant, preventing me from the rights to hire a lawyer, and cover up their bribery and blackmail I was reporting from the start.

Also have to say the Police was informed and willing to help with the recording of the report.

I DEMAND TO PRESS CHARGES

- against Italian Foreign Office for the assistance I had from the Consulate in becoming paperless like an illegal immigrant. In fact not only my passport was unavailable but also my university degree, making the perfect impostor out of me.
- against the Prosecutors Corrado Carnevali (Milan) and Guido Papalia (Verona) for mafia, for pretending it didn't happen and cover up "the colleagues" (Verona University, Questura of Milan, Comune of Milan).
- against the President of the Italian Republic, for mafia.

Dear President of the Italian Republic, if it was really Mussolini to invent Fascism, I would call you a Fascist. But it was not Mussolini to invent the Values of the Concordat and the "Roman Supremacy", and Religion is the only excuse.

Following your letter (page 181) I understand your best students like Kyenge and Regeni may have secular recommendations from the Bishop for diplomas and degrees they never had, because they are above the average and very obedient. Meanwhile the others cannot have confirmation of their true academic career from the secular university of the state you represent, become paperless like illegal immigrants and get arrested as terrorists for claiming their secular rights. Can you see your Consulate doing this? Nevertheless I do insist your offices have no rights to make people paperless and look like impostors, and your Courts of Justice have no rights to sweep the lawsuit into the afterlife.

Mussolini was doing the same for the same reasons, but I would excuse all of this as a mistake, a misunderstanding, if any of your best recommended students or professors could tell one democratic value that has ever been a catholic value in history; maybe the freedom of choice, or the secular value of Justice?

I understand false accusations, bribery and blackmail are Catholic Values and Virtues, Culture and Tradition difficult to eradicate, and you respect this system of values more than the secular law of the State. Nevertheless I have no intention to be the impostor to cover up the religiously educated brotherhood of a bunch of good principled mobsters you represent.

If I am doing this, Mr President, it is for the civic sense you have lost several compromises ago; the secular value of the rule of the law is a sign of civilization whatever you like it or not, but I understand your moral leader feels above it, and so you.

I DEMAND TO PRESS CHARGES

- against the false accusations I had to suffer in England, as retaliations and cover-up. A series of unsubstantiated accusations made up by Flannigan and motivated to cover up the situation and the Italian Consulate, a few years after the EU sent lawsuit to Italy.
- against PM Tony Blair and MP Bill Rammell for failing to inform EU concerning the situation (2008, pag 207), but rather tolerating the evidence of EU Citizen made paperless within EU Borders. In the reply suggested to press charges in Italy but shortly after I was targeted with false accusations.
- against Dr Flannigan for Political use of Psychiatry, for perverting the course of Justice with false accusations, for abuses and TORTURE, for reducing people into SLAVERY (Paul Diamond, barrister, 2008, pag 225) and for CATHOLIC RACISM

- Concerning false accusations and false arrest

I have been arrested because of the false accusations Dr Flannigan organised with the pretence, the excuse, the victims may have good reasons to turn into terrorists, may organise revenge and mass murders, so will be better arrest them and put them in isolation. The point is that people cannot claim the rights they are supposed to have, and if they do so, if they demand their secular rights, they may be arrested as terrorists under anti-terrorism laws, and the victims are vanished in isolation with the recommendations of good principled and honest psychiatrists.

Dr Flannigan handed me over to Dr Dissanayaka; you can hear the voice of Dissanayaka commenting on the happenings in the audio recording (attachment).

Dr Flannigan also made more precise recommendations to Dr Dissanayaka to question me because in her mind I was speaking badly about the Catholics, and Dissanayaka have questioned me about it. As matter of facts Dr Flannigan took advantage manipulating the ignorance of Dissanayaka to target me with her catholic motivated racist attack. So I do press charges against Dr Flannigan for MANIPULATION, FALSE ACCUSATIONS, and CATHOLIC RACISM as she reported to Dissanayaka, and the ABUSES and TORTURE she organised as retortion until I was handed over to Dissanayaka.

Concerning the delirium of Dr Flannigan and the false accusations she made, pretending the victims may become terrorists and plot mass murders, I was claiming my rights not to be the impostor when she decided I was better arrest into a psychiatric unit for terrorists to protect the public. She imposed on me to be the impostor to cover up the Catholic system of bribery and blackmail I reported from the start, and she did in conscience the best recommendations she could with false accusations of all kind and perverting the course of Justice.

In fact Dissanayaka believed Dr Flannigan pretending the democratic values are catholic values, but only because prejudice and preconceptions because none of them moralists inquisitors would be able to tell one democratic value that has ever been a catholic value in history. In fact our democratic values, the freedom of choice and the secular value of justice, are catholic heresies and have been persecuted throughout history as heresies for heretics, and then Anarchists, Communists, and now Apostates.

Since Dr Flannigan cannot tell one democratic value that has ever been a Catholic value in history, it is not me speaking badly about the Catholics. The problem is the prejudice and preconceptions they impose as good education, and the rights they pretend to oppress their victims in the name of their tradition of bribery and blackmail I reported years before Flannigan arrived with false accusations, lies and insolence, in conscience as Public Officer.
